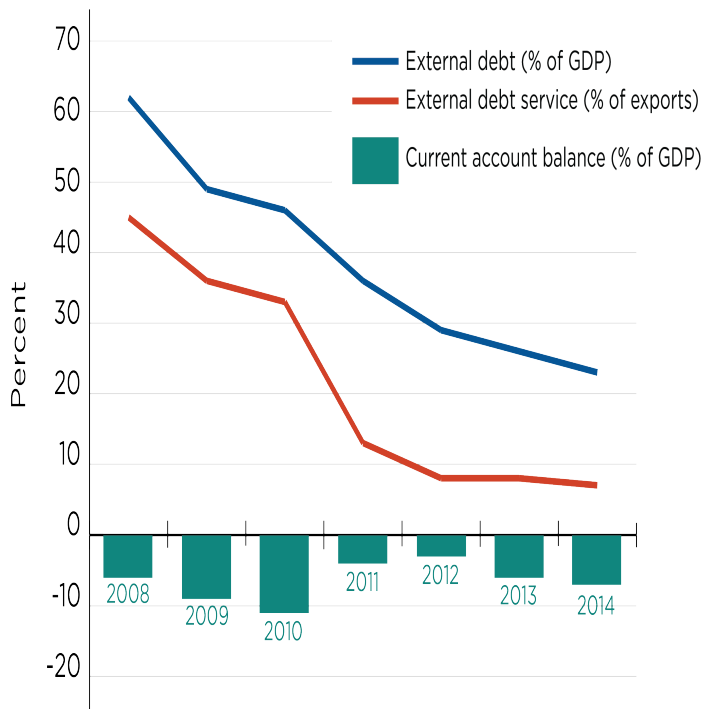


# Transparency And The Financial Structure Of The International Monetary Fund: Hearing Before The Joint
